

Alvernia University 2024 Nonpartisan Democratic Engagement Action Plan

Executive Summary:

This nonpartisan democratic engagement action plan was developed by Alvernia University in Pennsylvania for the 2024 election. The purpose of this action plan is to increase nonpartisan democratic engagement and student voter registration, education, and turnout in the 2024 election. The goals for Alvernia University for the 2024 election are:

- Reposition Student Voter Engagement within the Holleran Center for Community and Global Engagement rather than the Veterans Center
- Launch comprehensive social media campaign through main university accounts
- Educate Federal Work Study students on nonpartisan engagement
- Engage Berks County League of Women Voters to do voter registration drives on campus
- National Voter Registration Day campaign What Voting Means to Me linked to education around Constitutional Amendments impacting voting rights
- Civil Discourse Series and Holleran Lecture
- National Voter Education Week efforts, including social media campaign, sample ballot education, and vote tripling initiative
- Vote Early Day efforts, including videos from campus leaders
- Spring launch of Unify America initiative

Commitment:

Alvernia University is fully committed to nonpartisan democratic engagement. Our mission statement calls on all in our community to be ethical leaders with moral courage. We believe this includes or commitment to the democratic process. Similarly, our core values call us to peacemaking and collegiality, both essential to the democratic process. This year we have launched a civil discourse series tackling sometimes divisive issues like campus protests and presidential elections. We are partnering with the Berks County League of Women Voters of student voter registration efforts, and we are planning a collaboration with Unify America to launch in Spring 2025. Our president is a signatory to the ALL IN Presidents' Commitment to Full Student Voter Participation.

Landscape:

Alvernia University is a private 4-year institution and joined the ALL IN Campus Democracy Challenge in 2017. Our institution is designated as the following: Predominantly White Institution, and we have enjoyed a demographic shift in recent years that has positioned us as an emerging Hispanic-Serving Institution.

Alvernia University voting efforts conform to state regulations including:

- Elections in Pennsylvania are run locally, with state oversight. All told, more than 45,000 election workers and officials ensure Pennsylvania's elections are safe, secure, and accurate.
- In order to legally vote in elections in Pennsylvania, you must:
 - Be a U.S. citizen;
 - Be 18 years or older by Election Day;

- Be a Pennsylvania resident;
- Not be confined in a prison, jail, or other penal institution serving a sentence for conviction of a felony as of the date of the election and will not be released before the next election; and
- Not have been convicted of a violation of a provision of the Pennsylvania Election Code within the last four years.
- Election officials in each county regularly perform a rigorous review of the voter registration rolls, and eliminate people who do not meet the qualifications.
- To register and vote in any election district in Pennsylvania, you must have resided there
 for at least 30 days prior to voting. (Note: If you moved within 30 days of a presidential
 election, both federal and state law allow you to vote for President in your previous
 place of residence if you haven't already registered at your new address).
 Pennsylvanians must also be registered to vote at least 15 days before the election to
 qualify.
- There are 3 types of ballots in Pennsylvania:
 - o Mail-In Ballot
 - o Absentee Ballot
 - In-Person Ballot
- Pennsylvania voters can cast their ballot in 3 ways:
 - o By Mail
 - Via Secure Drop Box
 - In-Person on Election Day
- All ballots in Pennsylvania are subject to strict chain of custody requirements, which means non-partisan election officials are legally required to monitor and track every ballot through each stage of the process. This includes ballots that arrive by mail, as well as those placed in secure drop boxes or cast in person.
- Vote counting is overseen by non-partisan election workers (also called "election officers") in your county. Additionally, poll watchers from all political parties that appear on the ballot can observe ballot processing and tabulation.
- On Election Day, each precinct delivers its results to county officials, who are responsible for tallying, checking, and certifying the results.

Key dates in the state of Pennsylvania are:

- October 21 Last Day to Register to Vote
- October 29 Last Day to Apply for Mail Ballot
- November 5 Election Day

We are also designing programming for the following Civic Holidays:

• National Voter Education Week – October 7-11

• Vote Early Day – October 29

Goals:

Our institution's nonpartisan democratic engagement goals are:

- Goal 1: Increase student voter turnout rate to 85% in 2024 and 50% in 2026.
- Goal 2: Increase student voter registration rate to 84% in 2024 and 48% in 2026.
- Goal 3: Embed Unify America as civic engagement and civil discourse tool.

Strategy:

Alvernia University will implement these strategies to increase nonpartisan democratic engagement and student voter participation.

- More Deeply Embed Civic Engagement in our Mandatory Search First-Year Seminar
- Utilize the Holleran Lecture Series to Bring Speakers to the University that will Spur Student Democratic Engagement
- Engage Civic Engagement through the Civil Discourse Series
- Embed Unify America as a Civic Engagement and Civil Discourse Springboard
- We are also designing programming for the following civic holidays:
 - National Voter Education Week October 7-11
 - o Vote Early Day October 29

Evaluation:

Alvernia University will evaluate our action plan in the following ways:

- The National, Study of Learning, Voting, and Engagement to evaluate the increase of student voting by comparing our campus voter turnout and voter registration rates to past elections to measure progress on increasing both.
- We will closely monitor attendance at and participation in the following:
 - Civil Discourse Series
 - Holleran Lecture
 - Unify America
