Executive Summary:

This nonpartisan democratic engagement action plan was developed by Golden West College in California for the 2024 election. The purpose of this action plan is to increase nonpartisan democratic engagement and student voter registration, education, and turnout in the 2024 election. The goals for Golden West College for the 2024 election are:

Build a team: Campus Life identified the Associated Students of Golden West College (ASGWC) and their Student Interest Committee. The primary role of the Student Interest Committee is to educate students on policy and legislation and to support legislative action through student advocacy efforts. Additionally, Campus Life has onboarded a Professional Expert to assist in Civic Engagement project coordination.

Register students to vote: Our action plan includes regular voter registration drives, celebrating National Voter Registration Day each year, and providing students with voter registration information and resources throughout the academic year.

Educate students on issues and candidates: Our action plan includes strong partnerships with faculty, staff, administration, students, and community organizations to increase candidacy and issues awareness.

Help students to volunteer: Our action plan includes college-sponsored student trips, such as trips to Washington D.C., to volunteer in civic engagement activities and to encourage students to volunteer in partisan and nonpartisan campaigns of their choice.

Build election excitement and visibility: Our action plan includes a *Pledge to Vote Campaign, Ballot Bowl Outreach,* as well as visible election publicity.

Get out the vote: Our action plan ensures that we encourage students to vote early or on election day. We will email our students and post on our various social media outlets as a reminder to vote on Election Day. We will also host an early county vote center and have a permanent ballot drop off box located near the entrance to campus.

Leadership:

Our leadership team includes the following, campus groups, and organizations:

At Golden West College, our support is universal across administration, faculty, staff, and students. Specifically, President Meridith Randall, Vice President of Student Services Dr. Claudia Lee, and Dean of Students Dr. Carla Martinez have been supportive of this work. They worked with Campus Life to secure the logistics and board approval of the early Orange County Vote Center, attended campus lectures and events, sent emails in support of voter engagement, and encouraged campus-wide participation in civic engagement activities.

Campus Life also benefited from partnerships with our sister colleges, Orange Coast College and Coastline College, hosting district-wide Civic Engagement events such as National Voter Registration Day, faculty lectures, and educational forums in partnership with the Orange County Registrar of Voters. The three Coast colleges met once a month to coordinate districtwide Civic Engagement events and activities that expanded educational learning opportunities to all students across the district.

Commitment:

Golden West College does not have a current signatory to the ALL IN Presidents' Commitment to Full Student Voter Participation.

The Campus Life Department been in constant communication with outside nonpartisan partner organizations such as OC Registrar of Voters & League of Women Voters to get them on campus for holidays such as National Voter Registration Day National Voter Education Week, etc.

Landscape:

Golden West College is a public community college and joined the ALL IN Campus Democracy Challenge in 2021. Our institution is designated as the following: Minority-Serving Institution, Asian American and Native American Pacific Islander-Serving Institution, Hispanic-Serving Institution.

Our campus demographic and voting data:

Golden West College has 11,396 students.

Golden West College authorized the National Study of Learning, Voting, and Engagement (NSLVE) and received campus voting data for the 2022 election in fall 2023. However, our

NSLVE authorization expires in 2023 and our institution will need to reauthorize NSLVE to receive campus voting data for the 2024 election and beyond.

Our 2022 campus voting rate was 23.7% Our 2022 campus voting registration rate was 65.1%

Our 2020 campus voting rate was 56.7%. Our 2020 campus voter registration rate was 71.1%.

Golden West College has been recognized by ALL IN with the following seals of recognition for past elections: 2020 Bronze.

Golden West College participates in the following initiatives to support the development and implementation of our nonpartisan democratic engagement efforts on campus: National Voter Registration Day, National Voter Education Week, Vote Early Day.

Goals:

Our institution's nonpartisan democratic engagement goals are:

ASGWC has been successful in including civic engagement efforts in the scope of duties of the Student Interest Committee since 2019. Nonetheless, campus-wide civic engagement efforts across Golden West College and the Coast Community College District can be strengthened by institutionalizing best practices and ensuring all students are participating in the democratic process. Our goals for Civic Engagement and Voter Empowerment leading into the 2024 Primary and General Elections are as follows:

- 1) Ensure that all eligible Golden West College students have the tools and resources they need to be active participants in the electoral process.
 - a. We will incorporate voter registration and voter resources at more student events. In the upcoming year, we will collaborate more with Athletics and Student Clubs and Organizations.
 - b. Many of the questions students have about voting can be answered by visiting the Civic Engagement tile on the GWC Mobile App. Through clearer and more visible signage, use of student media outlets, campus emails, and a prominent highlight on the Golden West College homepage, we hope students come to learn about it and use it more widely.
 - c. The Golden West College academic calendar incorporates key electoral dates, including but not limited to, registration deadlines, election dates (including primaries), early voting timelines, and absentee ballot deadlines.
 - d. Our campus has collaborated with the Student Vote Project to assist students in the registration process and keep them up-to-date on relevant election information.
 - e. Golden West College will continue to publicize and host watch parties for political debates.
 - f. Nonpartisan candidate and issue guides are widely distributed and available for students.

- g. The Student Interest Committee will host educational forums on the issues in partnership with the Orange County League of Women Voters and the Orange County Supervisor of Elections Office.
- h. Golden West College will continue to collaborate with the Orange County Registrar of Voters to host an Orange County Vote Center.
- 2) Create spaces for healthy, deliberative dialogues across campus, so that students understand how this type of discourse is integral to the democratic process and active citizenship.
 - a. Strengthen the partnership between the Campus Life and GWC faculty to host more Civic Engagement events and yield higher attendance and participation.
 - b. Continue to host open lectures and Town Halls to include faculty from a variety of disciplines to serve our diverse student body.
 - c. Use social media to model the way on how to engage in purposeful digital discourse.
 - d. Provide student leaders with training on how to facilitate deliberative dialogue online and on-campus
- 3) Increase voting registration from 30.6% in 2024 to 37% in 2026 to meet the median voting rate of all institutions.

Strategy:

Golden West College will implement these strategies to increase nonpartisan democratic engagement and student voter participation.

Evaluation & Reporting:

We will evaluate our action plan in the following ways:

Golden West College will use the National Study of Learning, Voting, and Engagement to evaluate the increase of student voting by comparing our campus voter turnout and voter registration rates to past elections to measure progress on increasing both.

Golden West College will work with our internal Office of Research, Planning, and Institutional Effectiveness (ORPIE) to develop qualitative and quantitative data that demonstrates the overall success of our events and efforts. We will also implement a survey instrument at event check-ins to continue measuring similar elements in collaboration with the ORPIE office.
