

# Landmark College 2024 Nonpartisan Democratic Engagement Action Plan

## Executive Summary:

This nonpartisan democratic engagement action plan was developed by Landmark College in Vermont for the 2024 election. The purpose of this action plan is to increase nonpartisan democratic engagement and student voter registration, education, and turnout in the 2024 election. The goals for Landmark College for the 2024 election are:

- Engage all eligible students in the 2024 Presidential election by hosting voter registration events
- Facilitate absentee and in-person voting for students

#### Commitment:

Landmark College has signed the ALL IN's Presidents' Commitment to Full Student Voter Participation.

This is the first election cycle in which our institution has developed a nonpartisan democratic engagement action plan for the ALL IN Campus Democracy Challenge.

The College's mission statement reads:

Landmark College's mission is to transform the way students learn, educators teach, and the public thinks about education. We provide highly accessible approaches to learning that empower individuals who learn differently to exceed their aspirations and to achieve their greatest potential. Through the Landmark College Institute for Research and Training, the College aims to extend its mission across the nation and throughout the world.

The All In Campus Challenge commitment is woven into the mission statement by how we transform how students learn and how we empower individuals to achieve their greatest potential by becoming an informed electorate.

The curricular activities supporting the All In challenge involve a class presented during the fall 2024 semester titled Media Production and Political Communication, which will assist in crafting messages for distribution across our radio, TV, and internet publication channels. Students involved in the Student Government Association, Centers for Diversity and Inclusion, and the various honors societies will be engaged in voter registration and early/absentee voting drives.

# Landscape:

Landmark College is a private 4-year institution and joined the ALL IN Campus Democracy Challenge in 2024. Our institution is designated as the following: Predominantly White Institution, Rural Serving Institution

Our campus demographic and voting data: Landmark College has 467 voting-age students on campus during the Fall 2024 semester. BIPOC Student percentage: 19% Over 96% of students are out-of-state Landmark College students are 97% residential All students have learning differences. 50% of students are Autistic; the other students have a wide range of learning differences, including ADHD and Dyslexia

Student count by age range: 18-24 years of age: 414 25-34 years of age: 49 Over 35 years of age: 4

Male: 297 Female: 166 Non-binary: 7

Since most students will be voting absentee in their home states, we will use vote.gov to assist students with registration and absentee voting. If absentee voting for a particular state becomes impossible, we will guide the student to register to vote in the state of Vermont, which may be done as late as November 5, 2024, and assist the student in getting to the appropriate polling location using campus shuttles.

Landmark College has authorized the National Study of Learning, Voting, and Engagement (NSLVE).

### Goals:

Our institution's nonpartisan democratic engagement goals are:

- Increase student voter turnout rate to 75% in 2024 and 90% in 2026.
- Increase student voter registration rate to 80% in 2024 and 95% in 2026.
- Add 6-12 voter registration and voting events across campus during fall 2024.

### Strategy:

Landmark College will implement these strategies to increase nonpartisan democratic engagement and student voter participation.
