# **ACADEMIC ENGAGEMENT**

Dying to Vote is a documentary made by Loki Mulholland that was shown on campus for the larger campus community including students, faculty, staff and the larger area community. Moderated by Jerry Mitchell, an American investigative reporter formerly with *The Clarion-Ledger*, a newspaper in Jackson, Mississippi. He convinced authorities to reopen many cold murder cases from the civil rights era, his investigations providing the basis for prosecutions, prompting one colleague to call him "the South's Simon Wiesenthal". In 2009, he received a "genius grant" from the MacArthur Foundation. The documentary focuses on the experience of Dennis Dahmer, son of Vernon Dahmer. Vernon was an American civil rights movement leader and president of the Forrest County chapter of the NAACP in Hattiesburg, Mississippi. He was murdered by the White Knights of the Ku Klux Klan for his work on recruiting Black Americans to vote.



# **STUDENT ENGAGEMENT**



Students created a campaign called "Go Vote, Go Majors" to encourage voter registration. A partnership with a local organization, Mississippi Votes, was developed to assist Millsaps students with registering to vote. Mississippi Votes is an organization of intergenerational synergy centering and led by young people invested in the progression of Mississippi. We do this through our programming and outreach strategies that empowers young people, encourages civic engagement, and educates communities on voting rights through place-based grassroots organizing. Millsaps Young Democrats, Millsaps College Republicans and the Millsaps National Panhellenic Council (NPHC) were also engaged in the planning and support for voter registration activities.

# **Recommendations**

- Millsaps College should formalize a civic engagement committee made up of staff, faculty, students. This committee would be responsible for campus-wide coordination of activities related to voter engagement and registration. A centralized cross section of the campus would provide for an understanding of programming and overall civic engagement.
- The formation of a student organization dedicated to civic and voter engagement to bring student awareness to the forefront of the conversation. This group could work with the proposed committee to facilitate campus activities related to these efforts.

Overall, our future goals are to understand if civic engagement efforts are effective in increasing student awareness as well as participation in the areas of voter registration, education, and participation. As we continue to develop these efforts, we would seek information that will help us with continuous improvement related to civic engagement including developing stronger community connections and provide support for overall advocacy for this work to ensure that civic engagement and voting is a College priority that is supported with some institutional resources.
