This nonpartisan democratic engagement action plan was developed by Morgan State University in Maryland for the 2024 election. Commitment:

We are currently taking steps to strengthen our department's civic engagement functions to fully executive the goals and initiatives. This is the first action plan that Morgan State University has developed and submitted to ALL IN.

Landscape:

Morgan State University (MSU), a Carnegie-classified Doctoral/Research University (DRU) in northeast Baltimore. MSU, founded in 1867 provides instruction to a multiethnic, multiracial, multinational student body, offering more than 100 academic programs leading to degrees from the baccalaureate to the doctorate. As an anchor institution and Maryland's Preeminent Public Urban Research University, Morgan fulfills its mission to address the needs and challenges of the modern urban environment. MSU is a major economic engine for the city and state annually producing \$1 billion in statewide economic impact, supporting 6,500 jobs and generating \$47 million in state tax revenues.

Located in a charming residential area of northeast Baltimore, Morgan's impressive, 152-acre campus features state-of-the-art facilities geared toward innovative teaching and learning in the 21st century. Morgan State University has authorized the National Study of Learning, Voting, and Engagement (NSLVE) and will receive campus voting data for the 2022 election in fall 2023. However, our NSLVE authorization expires in 2023 and our institution will need to reauthorize NSLVE to receive campus voting data for the 2024 election and beyond.

Goals:

Our institution's nonpartisan democratic engagement goals are:

- Have our president/chancellor sign the <u>ALL IN Higher Education Presidents'</u>
 <u>Commitment to Full Student Voter Participation</u> by December 2023.
- Increase Voter Registration, Education, Ballot Access & Voter Turnout
- Collaborate with several student organizations and university departments to engage in our programming as partners and sponsors

• Provide a nonpartisan platform for candidates to share their vision and for students to inquire about how these candidates will be beneficial to their needs as students

Strategy:

Morgan State University will implement these strategies to increase nonpartisan democratic engagement and student voter participation.

VOTER REGISTRATION

Through a series of events hosted by campus organizations and the Office of Student Life & Development, our goal is to reach 100% of the student population on the campus of Morgan State University.

VOTER EDUCATION

We will provide sessions, seminars, panels & rallies around understanding the elections and voting process in partnership with organizations such as, the Baltimore Banner, National Society of Leadership & Success, NAACP, Black Girls Vote, Baltimore Votes & more. In these sessions students will be allowed to ask questions and engage with officials to learn useful voter information.

BALLOT ACCESS

In addition to providing students with information on their polling zones and absentee ballot, Morgan State University has been designated as a polling site for the U.S. and Local Elections.

VOTER TURNOUT

Our goal is for students to be able to register through the events hosted on campus & submit their ballots.

Evaluation:

We will evaluate our action plan in the following ways:
