# Northern Arizona University Spring 2024-Spring 2025 Action Plan

# I Executive Summary

The NAU Votes! Coalition has drafted the following Action Plan for the Spring 2024 semester and the 2024-2025 academic year, which will guide our efforts to increase voter registration, participation, and education/awareness across Northern Arizona University. This action plan was created and will be implemented in collaboration with NAU Votes! Coalition partners (listed below) including the Associated Students of Northern Arizona University, key faculty members, community partners such as the Arizona Students Association, and staff from the Office of the Dean of Students. The plan will primarily be implemented at the Flagstaff campus of NAU, though we hope to build communication and encourage voter engagement with the NAU satellite campuses and all online students. Key goals for this upcoming election year include:

- Increase total voter turnout rate from 62.3% in 2020 to 66%
- Increase voter registration rate from 82.3% in 2020 to 85%
- Increase the voting rate of registered students from 75.8% in 2020 to 77%
- Reduce the number of provisional ballots submitted by NAU students by ensuring that students understand how to cast their ballot and make it easier to vote in person or submit their mail-in ballot by encouraging them to register in Flagstaff.
- Work with faculty implementing the new General Studies curriculum (launching in the 2025-2026 academic year) to incorporate voter registration and civic education into classes fulfilling the American Institutions requirement
- Build capacity and distribute leadership for voter registration and engagement efforts
  - O The undergraduate student government (Associated Students of Northern Arizona University, ASNAU) will now house voter registration initiatives and information on the Flagstaff NAU campus in an attempt to increase student awareness and engagement. In collaboration with faculty, staff, and community partners, there will also be a student executive position within ASNAU (Vice President of External Affairs) committed to overseeing the NAU Votes! Coalition on campus and promoting our efforts with the NAU student body.

With the strong support of NAU President Jose Luis Cruz Rivera, who has signed the All IN Presidential Commitment, and by broadening participation in the NAU Votes! Coalition to include a more diverse range of student voices and campus organizations, we believe that we can be successful in achieving these goals.

## **Background**

Northern Arizona University is a public university with a student population of 28,194 at its main campus in Flagstaff and at 26 sites across the state and online. Popular majors include nursing, psychology, biomedical science, criminology and criminal justice, and education, and the school is known for its programs in forestry, environmental studies, hotel and restaurant management. NAU is a Hispanic Serving Institution and includes commitment to Native

Americans as one of its key strategic goals. Northern Arizona University sits at the base of the San Francisco Peaks, on homelands sacred to Native Americans throughout the region. We honor their past, present, and future generations who have lived here for millennia and will forever call this place home. Other objectives of NAU's strategic plan, relevant to our Civic Action Plan, are to integrate community engagement into academic curriculum and university policies and practices.

### **NAU Votes! Coalition**

During the 2019-2020 academic year, NAU joined the All-In Democracy Challenge. In anticipation of the 2020 elections, the NAU Votes! Coalition was formed in June 2020 to create a unified, campus-wide civic engagement effort. Our primary goal is to increase voter registration and participation and to integrate civic engagement into aspects of the university. The effort was spearheaded by the College of Social and Behavioral Sciences, with leadership from the Community Engagement Minor in the Sustainable Communities Program. In June 2020, this truly became a campus-wide effort. This action plan was created and will continue to be implemented during 2024-2025 in collaboration with NAU Votes! Coalition partners:

For the 2022-2023 academic year, we began to expand our outreach from the NAU Flagstaff Mountain Campus to also include the NAU Yuma Campus. In spring of 2024 and the 2024-2025 academic year, we plan to make connections with other satellite campuses and online students to support an increase in voter registration and participation beyond Flagstaff and Yuma.

### **2022-2023 Efforts**

In 2022-2023, the NAU Votes! Coalition continued its efforts to register and educate voters and encourage voter participation. These efforts included: emails to professors, classroom visits, voter registration phone and text banks, integration of voter registration links into University

websites, voter registration announcements, all-campus emails from the president's office, push notifications on the NAU GO app, and voter education events. Community Engagement Minor students working with Arizona Students Association sponsored a Halloween-themed "Who's Boos on Your Ballot" event to educate students about the November 2022 ballot initiatives and elected offices. The Coalition also sponsored a City Council Candidate Information Session over Zoom with several of the candidates for Flagstaff City Council. We strengthened our partnership with Campus Living this year and were able to provide voter registration training for Community Assistants over the summer, so that they could encourage voter registration at dorm events throughout the year.

We also administered a faculty survey in December 2022 to receive feedback on our efforts to make class presentations and provide support to faculty seeking to provide voter registration and education information. We received more than 50 responses. Those results are shared below and have helped to inform our ongoing efforts.

#### **II Commitment**

During the 2022-2023 academic year, the NAU Votes! Coalition was able to continue receiving support from NAU President, Jose Luis Cruz Rivera, who signed on to the Presidents' Commitment to Full Student Voter Participation and gave his full support to the Coalition's efforts. We were also able to secure a commitment to include coordination of the NAU Votes! Coalition in a new position in the Office of Student Affairs and to bring the coalition under the auspices of the Associated Students of NAU, our undergraduate student government. The new ASNAU Operations Assistant Manager, Erica Kragness, was hired in May 2023 and is now supporting our Associated Students of Northern Arizona University (ASNAU) Vice President of External Affairs, Callie Lowe, in leading the Coalition. As a result of the work of the Coalition, NAU's voter engagement efforts have begun to receive campus-wide recognition. We hope to build on these efforts and work with the NAU administration to integrate civic engagement across the curriculum and co-curriculum.

## III Leadership

At the end of the 2023 academic year, the NAU Votes! Coalition transferred leadership from Dr. Leah Mundell (faculty in Anthropology, Coordinator of the Community Engagement Minor, and advisor to the NAU Votes! Coalition since 2020) to the office of ASNAU. Dr. Mundell will continue her involvement in the Coalition, but the students in ASNAU, specifically the ASNAU Vice President of External Affairs, will oversee the initiatives proposed by the Coalition members. A change in leadership was mentioned in our previous action plan. As a student-led coalition, we believe there will be more opportunities to promote student engagement, involvement, and student-wide support. The Coalition has also partnered with the Coconino County Recorder's Office and the Coconino County Elections department, and representatives of those offices have started to participate regularly in Coalition meetings. We will continue our effort to expand and diversify the Coalition (in terms of political leaning, race, ethnicity, and field of study), identify more student leaders, and focus on recruiting new coalition members

for the coming years. Key participants are listed below and include faculty, staff, students, and community members.

# IV Landscape

The NAU Votes! Coalition demonstrates the breadth of NAU partners dedicated to enhancing civic engagement on campus. Beyond the coalition, civic engagement is fostered through programs such as the Community Engagement Minor. In this program, students acquire a broad education in democracy, power, and the skills that bring about change to enhance the commonwealth from the local level, to national and transnational scales through a series of intentional and sequenced learning experiences. At NAU, the general education program, formerly known as Liberal Studies, is currently being revamped with new requirements and with a new title of General studies that will be launched in the 2025-2026 academic year. One of the new distribution blocks will be American Institutions, which will include a heavy emphasis on civic education. We hope to build on this new focus by encouraging all American Institutions courses to include a voter registration and education component, which will be discussed during the 2024-2025 development of the General Studies curriculum.

We have not received the current National Study of Learning, Voting, and Engagement (NSLVE) numbers so we are basing our predictions for the 2024-2025 academic year on the 2020 NSLVE data. The 2020 NSLVE Campus Report showed a 16.4 point increase in NAU's voting rate, jumping from 45.9% in 2016 to 62.3% in 2020. Moreover, 82.3% of voter-eligible NAU students registered to vote in 2020 compared to 77.3% in 2016 and above the national average for comparable student voters. The voting rate for registered students was 75.8%, up from 59.4% in 2016.



We realize that it may be difficult to maintain these gains in the preferential, primary, and presidential elections in 2024. Voter turnout was significantly lower in 2018 than in 2016, with 33.6% of all students and 45.9% of registered students voting in the midterm elections. Nonetheless, these will be highly publicized races, attracting significant attention. Presidential elections will yield a high turnout in students.

A new key goal for 2024 will be to reduce provisional voting and rejected ballots submitted by our student population. According to the Coconino County Department of Elections, in 2022, there were 1014 provisional ballots submitted in all of Coconino County, and 319 of those (31%) were submitted at the NAU polling location. Almost all of those provisional ballots (97%) were rejected. Students might be submitting provisional ballots for several reasons:

- They do not know that their ballot must be received by election day in the county where they are registered to vote.
- They did not mail their ballot in time and hope that Coconino County will accept their ballot.
- They have moved to a new address within the county but not updated their voter registration.

We aim to encourage students to check that their voter registration is updated with the correct address, to register to vote in Coconino County, where they can easily vote up until election day, and to send in their ballot on time if they are registered elsewhere in the state or country.

Unfortunately, we do not have data from NSLVE disaggregated by race, ethnicity, or gender for 2016, 2018, or 2020. We will be exploring the possibility of reporting this data for 2024 so that we can better understand issues of equity in our voter registration and participation rates. A representative from the NAU Votes! Coalition will contact Tufts University to inquire about receiving NSVLE data that would be specific to race, ethnicity, and gender. Northern Arizona University has achieved the status of a Hispanic Serving Institution, with over 25% of our population identifying as Hispanic/Latine. We also have a strong institutional commitment to serving Native American students, with 5% of our student population identifying as Indigenous. In addition, 6% of students identify as Asian and 6% as African-American.¹ It will be critical for us to ensure that our voter registration and participation gains are reflected across these diverse populations. We are currently exploring student connections to diverse populations through ASNAU and their inclusive excellence branch and planning to implement these findings in our approach to all aspects of voter engagement at NAU.

In considering how we can expand our efforts beyond the Flagstaff campus, the largest population to include will be our Online/Personalized learning community, which comprises 4,741 students. By working with NAU's Student Affairs Strategic Initiatives (SASI) staff, we will explore the best methods for digital communication across the different departments in which students are enrolled. Some of these methods include: learning management systems notifications, email messaging to statewide students, push notifications via the NAU GO App, social media outlets, etc. We will also link the NAU Votes! Coalition website to ASNAU so that it is more widely dispersed to the NAU student population.

It will also be important for us to take into consideration our NSLVE data on the voting methods utilized by students to vote in the 2020 election. We saw a 24% increase in students utilizing other voting methods (likely mail-in ballots) than in-person from 2016 to 2020. There have been some changes to Arizona law since 2020 that will affect students' ability to vote by mail. SB 1485 allows a voter to be removed from the Active Early Voting List if they do not not "cast their mail ballot in at least one election over the course of two consecutive election cycles and fails to respond to an official notice from the county recorder or elections office." Also, in July of 2021, the U.S. Supreme Court upheld Arizona's 2016 law prohibiting turning in mail-in ballots for anyone other than a family member, so campus GOTV efforts cannot include collecting students' ballots and turning them in to the registrar's office.


Although we do not know how many students voted in other states, other counties, or precincts in other parts of Coconino County, we do know that turnout in the 2022 election from

the precincts surrounding NAU was fairly low.<sup>3</sup> In Precinct 13, which includes the NAU voting location, only 27.43% of registered voters voted in November 2022. Voter turnout in nearby precincts included:

Precinct 10: 38.15%Precinct 14: 39.49%Precinct 27: 43.13%



### V Goals

# **Voter Registration and Turnout Goals**

For the 2024 general election, we are utilizing data from the 2020 general election as the baseline for setting our goals. The goals are:

- Increase total voter turnout rate from 62.3% to 66%.
- Increase voter registration rate from 82.3% to 85%.
- Increase the voting rate of registered students from 75.8% to 77%.
- Decrease provisional voting rejected ballots by increasing education and awareness amongst voters, especially students.
- Work with the Coconino County elections department to increase voter awareness of the three upcoming elections in the 2024 cycle.
  - O Advertise student poll worker positions that will be accessible through the Help America Vote service day mini grant program (provided by the U.S. Election

Assistance Commission), which will be a collaborative effort between the NAU Votes! Coalition and the Coconino County Elections office.

## **Civic Engagement Goals**

- Increase participation in the NAU Votes! Coalition, especially among organizations and clubs representing BIPOC students and diversity in politics, faculty from across a wider range of academic fields, and community partners including the Coconino County Recorder's Office and Coconino County Elections Department. Specifically, add at least two representatives of minority-focused clubs or organizations, two faculty members from outside Social and Behavioral Sciences, and a representative from the NAU Center for Service and Volunteerism.
- Secure a commitment from NAU President Jose Luis Cruz Rivera to make his commitment to the ALL IN Challenge public and to incorporate voter registration and GOTV information into his Fall 2024 campus-wide messages.
  - O Additionally, encourage messaging from the President's office before major registration or voting deadlines.
- Continue to engage faculty in incorporating both voter registration information and civic engagement into their curriculum and class activities.
  - Secure a commitment from the Provost and Dean of Students' offices to message faculty and staff promoting voter registration/information across NAU before each of the 2024 presidential preference, primary, and general elections.
- Work with faculty implementing the new General Studies (launched for the 2025-2026 academic year) curriculum to incorporate voter registration and civic education into classes fulfilling the American Institutions requirement.
- Increase dedicated staff/faculty/student worker time to voter registration and engagement efforts.
  - Encourage students, staff and faculty to participate in elections as poll workers, which will be promoted by ASNAU, NAU Votes! Coalition, and the Coconino County Elections office with support from the Help America Vote mini day grant.
- Hold In-person registration events during key moments of the term, including but not
  exclusive to Help America Vote Day, Welcome Week events, National Voter Registration
  Day, civic holidays, and the week leading up to the voter registration deadline.
  - Capitalize on NAU "signature" events, such as Welcome Week's "NAU Letters,"
     "Running of the Freshmen," Homecoming events, Family Weekend, etc.

### **Long term goals**

 In collaboration with our SASI team, we will explore the best methods for digital communications across various departments in which students are enrolled. Some of these methods include: learning management systems notifications, email messaging to statewide students, push notifications via the NAU GO App, social media outlets, etc.

- Increase voter engagement in student populations through information campaigns, inperson registration events prior to elections, and social media advertisements
- Collaborate with local and County officials throughout the academic year to increase voter registration and voter engagement and to reduce the number of provisional ballots cast at the NAU polling locations.

# VI Strategy and Tactics

Northern Arizona University, and the NAU Votes! Coalition, will continue to improve voter access and provide information to students about elections. Three key areas of focus are:

- 1. Voter Registration: Voter registration information will be focused on relaying state-specific information such as Arizona's vote by mail Active Early Voting List system. The Coalition also aims to communicate to out-of-state students that they have the opportunity to vote in Flagstaff while they are living in this community and attending NAU. Members of the Coalition are trained to answer questions about acceptable addresses and forms of ID. In order to register voters and increase registration rates on campus, we will implement the following:
  - a. Work with Arizona Students Association and AZPIRG Campus Action to provide easy online voter registration to students. Ensure that voter registration links continue to be included on the NAU Go App, Cline Library Website, and LOUIE (class registration and student accounts).
  - b. Work with faculty to integrate registration into their courses by:
    - Including voter registration on syllabi and course pages and potentially offering extra credit.
    - ii. Allowing NAU Votes! Coalition members to make non partisan in-class announcements.
    - iii. Emailing students on and around key dates in the election cycle.
    - iv. Incorporating a voter tool link in email bios.
    - v. Creating a to-do item in the student learning management system, Canvas, to ensure students register to vote.
  - c. Relay non-partisan registration announcements at club meetings and reach out to club/organization leadership to alert members about joining the Coalition, voting deadlines, and increased voter engagement.
  - d. Utilize push notifications and create a widget with voter registration links and information on the NAU Go App.
  - e. Encourage ASNAU, Student Affairs, Campus Living, the office of the Provost, the Dean of Students, and the President's Office to message NAU students about voter registration deadlines and important election information.
  - f. Work with ASNAU to sponsor a voter registration challenge among the academic colleges, with prizes and recognition for the college with the highest percentage of registered voters.
  - g. Host in-person registration events during special dates on the academic calendar, including but not exclusive to Welcome Week, Help America Vote Day,

National Voter Registration Day and other related civic holidays, and the week leading up to the voter registration deadline. Capitalize on NAU "signature" events, such as Welcome Week's "NAU Letters," "Running of the Freshmen," Homecoming events, Family Weekend, etc.

- h. Coordinate with Campus Living to include voter registration in their fall 2024 housing move-in checklist.
- Ensure that extended campuses and especially online faculty and students are included in campus-wide communications and other digital voter registration efforts.
- j. Request a resolution in the Faculty Senate to encourage faculty to refrain from scheduling assignments or exams on election day.

### 2. Election Information/education:

- a. In the early fall 2024, offer a Faculty Development workshop in conjunction with the Teaching and Learning Center on faculty rights and responsibilities for voter education.
- b. Integrate election information into Freshman and Transfer Student Orientation and Resident Assistant (RA) training.
- c. Maintain the NAU Votes! website with current voter registration and election information. The website will include FAQs, student voter ballot information, and instructions to vote.
- d. NAU Votes! Coalition, ASNAU, Civic Engagement Club, ASA, etc will continue to co-sponsor election information events at NAU, including a discussion of voter suppression, a campus debate among local and state candidates, a "Know Your Ballot" event to discuss propositions, and town halls to discuss voting specific inclusive practices.
- e. Create informative social media posts, which can be easily dispersed by Coalition members and student groups.
- f. Host nonpartisan candidate events for NAU students in the Fall 2024 semester
- g. Participate in a shared fall campaign with Big Sky Votes Coalition and All IN Democracy Challenge partners, including National Voter Registration Day, Voter Education Week, and Election Hero Day.

### 3. Voter Participation:

- a. Have a vote center in the ASNAU office on the NAU campus to make voting more accessible for students.
- b. Work with the Coconino County Recorder's Office to maintain a ballot drop box on campus.
- c. Publicize the NAU Votes! Coalition website with comprehensive voting information for NAU students.
- d. Collaborate with other clubs and organizations to promote student voting.
- e. Use data collected from https://azstudents.turbovote.org/ to encourage students to vote on campus.

f. Create a voter pledge competition among athletic teams, fraternities/sororities, and other clubs and organizations.

We will work to recruit and retain members of the NAU Votes! Coalition through the following strategies:

- 1. Maintain oversight of the NAU Votes! Coalition as a job requirement for the ASNAU Vice President of External Affairs (under the supervision of the ASNAU Operations Assistant Manager).
- 2. Include participation in the Coalition as part of the job description for the Director of Leadership and Engagement.
- 3. Recruit new staff members to the Coalition by presenting to the Student Affairs Division in fall 2024.
- 4. Recruit new faculty members to the Coalition by presenting to the Faculty Senate.
- 5. Recruit new student representatives to the Coalition by presenting to club/org presidents at their fall orientation.

#### VII Evaluation

## 2020 Evaluation


Two student members of the NAU Votes! Coalition, Madeline Snyder and Jaela Pipkins, conducted an evaluation of our 2020 voter engagement strategy, helping to guide our 2024 action plan and to provide a model for future evaluation efforts. Comparatively, 2020 yields the most similar voting data as it was the last presidential election year. In particular, they were able to track the specific success of our digital voter registration strategies:

- 1. NAU students use LOUIE to enroll in classes and as their one-stop student center. In Fall 2020, the NAU Votes! Coalition advocated for the addition of a "register to vote" push in students' "To Do List," which directed students to arizonastudentvote.org. Since this was a unique link, we were able to track that at least 100 registrations originated from the LOUIE link.
- 2. During the Fall 2020 semester the NAU Votes! Coalition website<sup>4</sup> was launched. The NAU Votes! Coalition website is linked to the NAU Division of Student Affairs (found under the "Resources" tab, listed as "NAU Votes! and voting resources") and the ASNAU website. The site contains information about how to register to vote, how to vote in person or by mail, important dates, and voter education events/information. There were 771 new users on the NAU Votes! website. New users accounted for 30% out of 2,538 total sessions. The NAU Votes! website in Fall 2020 contained important information regarding voting information and deadlines. Returning users accounted for 1,767 sessions, according to Michelle Gardner<sup>5</sup>.

- 3. According to the ASA data on the azstudents.org website, there were 450 registered voters from the TurboVote data and embedded voter registration link. Combined with online efforts and paper registration forms, the Arizona Students Association registered 4,088 new voters. This link was provided in class RAPs, in text messages to eligible voters, and posted on social media.
- 4. The arizonastudentvote.org link<sup>6</sup> (PIRG), reached 926 NAU students. Of the 926 students, 347 registrations came from class RAPs, 171 from Listservs, 155 from Campus Email, 148 from Other, 136 from Orientations, 100 from NAU LOUIE, 37 from Associated Students of Northern Arizona University (ASNAU), 37 from NAUgo, 10 from Social media, 5 Phone banks/texts, 2 from Professors, 1 from True Blue Connects, 0 from Cline Library and NAU Votes!.



5. The NAU Votes! Coalition also worked with ITS to add a voter registration link on the NAU Go app. A link to arizonastudentvote.org went live on the NAU Go app in July 2020 and generated 42 new registrations. We hope to generate even more new registrations with an earlier launch date this year.

#### **2022 Faculty Survey**

In December of 2022, we received 59 responses to a survey we distributed to faculty, asking them to reflect on the NAU Votes! Coalition voter engagement strategies for the November 2022 election. The results were useful for our planning efforts. That fall, 73% of respondents remembered receiving an email from students or organizations requesting to present voting information in their classes. 75% of respondents had discussed voting at least once in their classes, and 61% had presented voter registration information specifically (either on their own or with a presentation by an NAU Votes! Coalition member). The responses to these presentations were extremely positive, with faculty noting that student presenters were well

prepared, presentations were short (though some said they would have liked more detailed presentations!), and brought useful materials.

We also learned that very few faculty use other strategies to share voter registration information, such as posting it in their BbLearn shell, through email, or through BbLearn direct messages. Faculty who did not present voter registration information shared some important concerns in their comments, including:

- "Didn't have enough information"
- "I try to keep politics out of the classroom. That being said, voting is an integral part of society so I should probably bring it up more. On the other hand, everything has become political so I try not to open that door."
- "Content did not fit with class material"
- "Email instructions I received were not clear"
- "Unsure if group who contacted me was partisan or if presentation was allowed in class"

These comments have spurred us to consider how to educate faculty that providing voter information is both allowed and encouraged. In the coming year, we will ask the president and/or provost's office to address this in their faculty communication, offer a faculty development workshop on this topic, and continue to offer high quality class presentations to supplement the information that faculty provide themselves.

## 2024-2025 Evaluation Strategies

An evaluation team from the NAU Votes! Coalition, composed of students, faculty, staff and community representatives, will collect data (number and affiliations of participants) from our events, campus competitions, class presentations, and other efforts. This team will also gather feedback on our digital strategies, similar to the data collected for our 2020 evaluation, to see what is the most successful method for connecting from the student body. This process of evaluation will be ongoing throughout the 2024-2025 academic year and be especially effective after we receive our 2022 NSLVE data. We will also use an evaluation form to receive feedback on our planned faculty workshop.
