Executive Summary:

We have a comprehensive working group, (Campus Engagement Group) composed of faculty, staff, and student representatives, that has been promoting civic engagement, awareness, and involvement since the spring semester. Our campus website, https://www.sjcme.edu/vote/ was created by this working group, as well as a student at Saint Joseph's College working for the Campus Election Engagement Project (CEEP) in a partnership with Maine Campus Compact. We have hosted roundtable discussions with the State of Maine Secretary, Matt Dunlap, on National Census Day, and participated in Maine voter registration webinars and campus voting drives.

Involvement in our plan involves voter registration, awareness of political issues, student-specific issues (student loans, minimum wage, healthcare) as well as debate watch parties, voter registration drives, campus flyers, Election Day transportation from our campus ministry office, and involvement from our Political Science Club and Student Government Association.
