Executive Summary

This nonpartisan democratic engagement action plan was developed by Salve Regina University in Rhode Island for the 2024 election cycle. The purpose of this action plan is to increase nonpartisan democratic engagement and student voter registration, education, and turnout. The goals for Salve Regina University for the 2024 election are:

- Create a campus culture of civic engagement and responsibility by empowering students with the necessary information to fully participate in the democratic process.
- Enhance partnerships with community organizations, businesses, and government agencies to enhance civic engagement opportunities for students.
- Conduct Fall 2024 programming to enhance Salve student voter registration and turnout, including voter registration drives.

Commitment

This is the first action plan that Salve Regina University has developed for ALL IN.

Salve Regina University participates in the following initiatives to support the development and implementation of our nonpartisan democratic engagement efforts on campus:

- Actively promotes and markets Mercy mission, which involves active engagement in creating a world that is harmonious, just, and merciful.
- Active relevant student clubs include: College Democrats, College Republicans, Student Government Association (SGA), Black Student Union.
- Salve has conducted voter registration drives in the past, most recently during the 2022 mid-term elections, organized and staffed by SGA.
- SGA has also facilitated election-related discussions, most recently before and after the 2020 elections.
- Various University offices, programs, and organizations bring speakers to campus that increase public understanding.
- Salve's president has signed ALL IN's Presidents' Commitment to Full Student Voter Participation.

Landscape

Salve Regina University is a private 4 year institution with 2,817 students and joined the ALL IN Campus Democracy Challenge in 2024.

Salve draws most of its student body from New England States plus New York and New Jersey, therefore voting information from these states is most relevant. See index for state-specific information, including upcoming elections relevant to action planning, voter ID laws, vote-by-mail processes, and absentee ballots request timelines.

Goals

Our institution's nonpartisan democratic engagement goals are:

Short-term goals:

- Have president sign the <u>ALL IN Higher Education Presidents' Commitment to Full</u> <u>Student Voter Participation</u> by April 2024 (completed).
- Report student voting information to NSLVE in 2024 (completed; Salve has enrolled in NSLVE).
- Join Braver Angels RI Alliance (completed; Katie Sonder has joined).
- Identify and recruit at least two more Salve undergraduate students to join coalition by the start of the Fall 2024 semester.
- Host a series of civic engagement events in Fall 2024 (more information below).
- Create a SalveVotes Instagram account to share event and voting-related information. Identify social media manager to run account.

2025 goals:

- Once we receive our first NSLVE report, likely in Fall 2025, determine baseline and create additional S.M.A.R.T.I.E. goals (Specific, Measurable, Ambitious, Realistic, Timebound, Inclusive, and Equitable) around student voter registration and voter turnout.
- Host at least one post-election event during Spring 2025 semester.
- Brainstorm initiatives to enhance a culture of civic engagement beyond voting.

Long-term goals:

- Create a campus culture of civic engagement and responsibility by empowering students with the necessary information to fully participate in the democratic process.
- Enhance partnerships with community organizations, businesses, and government agencies to enhance civic engagement opportunities for students.
- Identify ways to embed civic engagement in student experience, e.g. include voter registration information session in new student orientation.
- Increase registration and voting rates by 5% between 2024 and 2028 presidential election years through our short and long term strategies.

Strategy

Salve Regina University will implement these strategies to increase nonpartisan democratic engagement and student voter participation.

- Coalition meeting in early September to finalize Action Plan after receiving feedback from All In.
- Identify how to obtain ballot drop off bins for mail in ballots and place in a central location around campus.
- Host three voter registration drives during the Fall 2024 semester.
 - Sept 17th: <u>National Voter Registration Day/Constitution Day</u> voter registration drive

 - October 29th: Vote Early Day/SRU civic engagement fair
 - The final registration drive will be part of a Civic Engagement Fair, which will highlight campus organizations focused on civic engagement. Students will have the opportunity to learn more about each club, sign up to join, and register to vote. We will also add interactive elements, like a raffle, snacks, discussion spaces, etc.

- Promote voter registration events through Salve Today, SalveVotes Instagram account, and student wide emails.
- The Pell Center, in collaboration with a student group (either SGA or College Democrats and College Republicans) will host one debate watch party and at least one roundtable session on political engagement and dialogue.
- Create plan to publish action plan and event calendar on Salve.edu and/or through Salve Today.
- Coalition meeting in January 2025 to identify post-election event opportunities.

Evaluation

We will evaluate our action plan in the following ways:

• Salve Regina University has authorized the National Study of Learning, Voting, and Engagement (NSLVE) to receive campus voting data to help with the evaluation of our action plan and nonpartisan democratic engagement efforts.

We will receive our first report on student voter registration and voter turnout in Fall 2025.

- Compile estimated attendee numbers for voter registration drives and events.
- Evaluate effectiveness of events and areas of opportunity during January coalition meeting.
