# **Executive Summary:**

This nonpartisan democratic engagement action plan was developed by San Bernardino Valley College in California for the 2022 election. The purpose of this action plan is to increase nonpartisan democratic engagement and student voter registration, education, and turnout in the 2022 midterm election. The goals for San Bernardino Valley College for the 2022 election are:

- 1. Increase civic engagement partnerships to 5 in 2022 and 8 in 2024.
- 2. Create a voter turnout rate baseline in 2022.
- 3. Increase student voter registration rate by 10% in 2024.
- 4. Increase student voter turnout rate by 10% in 2024.

#### **Goals:**

Our campus democratic engagement goals are:

- 1. Increase civic engagement partnerships to 5 in 2022 and 8 in 2024.
- 2. Create a voter turnout rate baseline in 2022.
- 3. Increase student voter registration rate by 10% in 2024.
- 4. Increase student voter turnout rate by 10% in 2024.

## **Strategy:**

San Bernardino Valley College will implement these strategies to increase nonpartisan democratic engagement and student voter participation.

- 1. REGISTRATION: Help students register to vote. Make registration easy, accessible, and convenient.
  - Peer-to-peer education outreach
  - Host voter registration drives (in-person and virtual)
  - o Promote annual Ballot Bowl
- 2. EDUCATION: Educate students about the importance of voting.
  - Provide nonpartisan information to students regarding upcoming ballot measures and candidates at the local, state, and federal levels
  - Peer-to-peer dialogue, registrar presentations, and distribution of informational materials.
  - Online resources/links for voting (website, Library, Presence, etc.)
- 3. TURNOUT: Promote voting. "Voting should be a habit, not a hobby."





- Include civic, voting, and registration dates/deadlines on physical and virtual academic calendars (SBCCD and SBVC)
- Email blasts to students about deadlines and events
- Social media
- Campus flyers/posting
- Collaborate with faculty to share important information/dates/deadlines
- **4. RECOGNIZE:** Recognize individual and community milestones--from registration, voting percentages, and volunteerism.
  - Recognize students, staff/faculty for their participation and efforts

### **Evaluation:**

We will evaluate our action plan in the following ways:

**HOW:** We will utilize a variety of methods to track and evaluate our campus democratic engagement programming including our Presence student engagement platform.

We will partner with our Institutional Research office to assist in finding gaps in our outreach, and reevaluate programming and outreach each semester.

**WHO:** The leadership team identified in this action plan, which includes faculty, classified professionals, and students – modeling the participatory governance democratic process – will meet each semester and as needed to coordinate civic engagement events and programs. The team will address gaps in engagement by partnering with faculty and programs that serve those underserved/under-engaged student populations.





**NSLVE:** San Bernardino Valley College has recently authorized the National Study of Learning, Voting, and Engagement (NSLVE) within the last few months, so does not yet have campus voter registration and voter turnout data.
