# Summary

This nonpartisan democratic engagement action plan was developed by the University of California, San Diego in California for the 2022 election. The purpose of this action plan is to increase nonpartisan democratic engagement and student voter registration, education, and turnout in the 2022 midterm election through an on campus campaign.

The campaign "Tritons Vote: Your Vote, Your Choice" features key voting infrastructure provided by the CA Secretary of State and the San Diego County Registrar of Voters such as a ballot drop box, a vote center and voter registration links.

**The goals for the University of California, San Diego for the 2022 election are:**

- Provide voting infrastructure for the campus and local community at large such as a ballot drop box and an election vote center;
- Develop or maintain a voter engagement campaign that is aimed at voter registration, education, and outreach;
- Maintain or increase funding resources to ensure voter engagement efforts are fully supported;
- Increase or maintain voter engagement numbers for a mid-term general election as follows:
  - Voter turnout rate at a minimum of 40% (in comparison to 2018)
  - Voter registration at a minimum of 75% (in comparison to 2018)

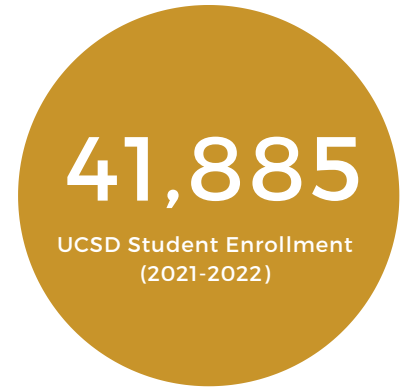

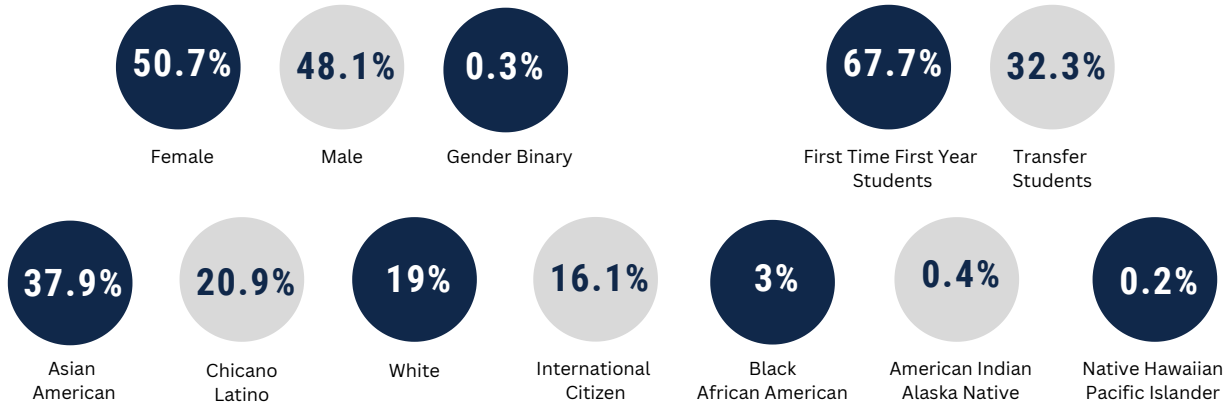


# LANDSCAPE

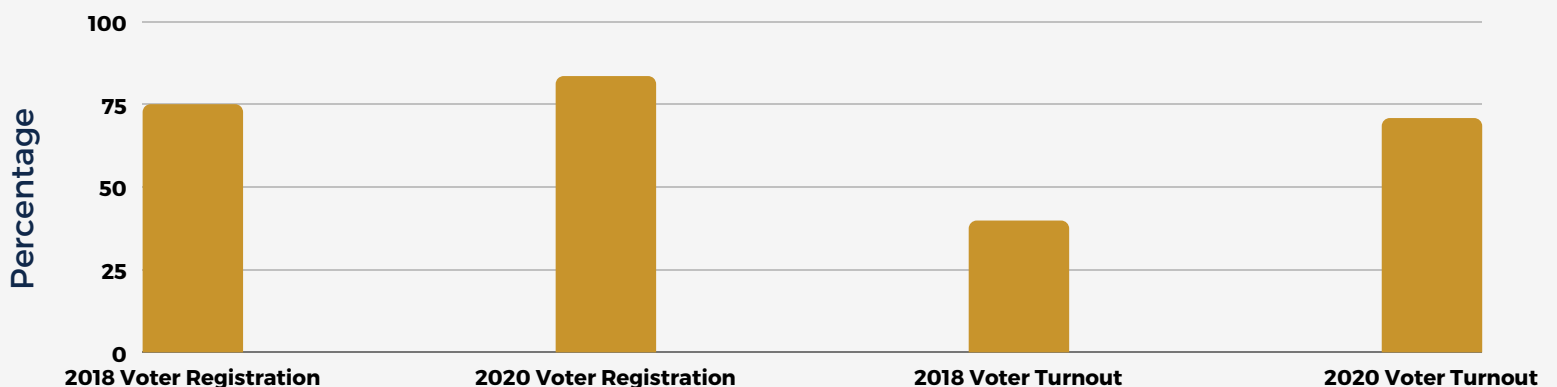


## Undergraduate Enrollment

# Goals & Strategies

#1

**PROVIDE VOTING INFRASTRUCTURE FOR THE CAMPUS AND LOCAL COMMUNITY AT LARGE WHICH MAY INCLUDE A BALLOT DROP BOX AND VOTE CENTER.**

**Strategy 1:** Develop a partnership with the San Diego County Registrar of Voters to establish a California Election Ballot Drop Box on the UCSD campus.

**Strategy 2:** Develop a partnership with the San Diego County Registrar of Voters to establish a Vote Center on the UCSD campus and allow it to serve the campus and local community during the election timeframe.

**MAINTAIN OR INCREASE FUNDING RESOURCES TO ENSURE VOTER ENGAGEMENT EFFORTS ARE FULLY SUPPORTED.**

**Strategy 1:** Secure funding through the Associated Students Office of Civic Engagement to fully support all voter engagement initiatives.

**Strategy 2:** Identify and utilize funding from the University of California Office of the President and LEAD California to support student participation.

#3

**DEVELOP OR MAINTAIN A VOTER ENGAGEMENT CAMPAIGN THAT IS AIMED AT VOTER REGISTRATION, EDUCATION, AND OUTREACH.**

**Strategy 1:** Utilize the “Tritons Vote” campaign and create the 2022 theme that will be utilized to promote voter engagement at UCSD with an emphasis at registering eligible voters to vote and to educate the campus community on the general election process.

**Strategy 2:** In partnership between the Associated Students and the Graduate & Professional Student Association, identify volunteers that will serve to register students to vote and engage with the campus community on voter education for 2022.

**Strategy 3:** Create a streamlined online process in the form of webpages for connecting the campus community to election resources such as the voter registration links from the CA Secretary of State, polling location finder, ballot box information, and policies on the election.

**Strategy 4:** Participate in national voter engagement events such as national voter registration day and election day to maximize voter registration, turnout, and participation.

**Strategy 5:** In partnership with UC San Diego’s Center for Student Involvement and the University of California Office of the President, develop workshops and webinars that focus on voter education.

#4

**INCREASE THE STUDENT VOTER REGISTRATION RATE TO 75% IN 2022 AND 85% IN 2024.**

**Strategy 1:** Utilize the “Tritons Vote” campaign to register students to vote through social media outreach, online voter registration links provide by the CA Secretary of State, on campus events, and onsite tabling across the university.



#5

**INCREASE THE STUDENT VOTER TURNOUT RATE TO 40% IN 2022 AND 75% IN 2024.**

**Strategy 1:** Identify and secure voting infrastructure such as a vote center, ballot box and online resources to ensure eligible voters are aware of election resources and are easily able to vote through mail or in person.



# Evaluation & Reporting

**We will evaluate our action plan in the following ways:**

- Number of students registered to vote as part of the California Secretary of State Ballot Bowl competition hosted by the California Students Vote Project.
- Number of student participants who created a voter action plan.
- Number of attendees at all UCSD voter engagement events (in person and online).
- Student feedback survey administered through the student governments of UCSD to be administered in early 2023 aimed at further enhancing civic engagement through election participation.
