#### Executive Summary:

This nonpartisan democratic engagement action plan was developed by William Paterson University in New Jersey for the 2024 election. The purpose of this action plan is to increase nonpartisan democratic engagement and student voter registration, education, and turnout in the 2024 election. The goals for William Paterson University for the 2024 election are:

#### William Paterson University Topline Campus Voter Engagement Goals

1. To bring awareness to our campus members of their rights and responsibilities as informed voters and members of the USA who reside in a global community;
2. To educate and engage our community in effective democratic processes and outcomes on and off campus;
3. To register all members of our campus community to participate in all elections such as campus elections, midterm elections, state elections, county elections, primary elections, fall 2024 elections, etc.;
4. To increase civic engagement on and off campus and after graduation;
5. To educate our community on issues on ballots, provide information on candidate profiles and positions, closing the loop by every member casting ballots in every election, and to become engaged members and change agents in their communities; and

6. To nurture, guide and provide spaces where our community can effectively strategize to let their voices be heard and their votes counted.

The commitment to civic engagement, voter education, voter registration, casting ballots, and helping students create the world that they want to live in and the next generation to inherit is woven into our recently revised Mission Statement. In addition, Civic Engagement will be more deeply embedded in our new University Core Curriculum 2.0, which will be rolled out in fall 2025 with an emphasis on learning by doing, case-based learning, and making the most of the regional landscape, which includes Paterson, NJ and the surrounding area. The commitment to nonpartisan democratic engagement is communicated to the campus community through the Office of Campus Activities, Service and Leadership via annual campus email campaigns, during on-boarding orientations and open house presentations, club fairs, weekly tabling, career, major/minor days, internship information sessions, and campus events focused on a variety of ways students and student leaders can incorporate service and civic engagement into their careers. In additions, with WP LEADS Civic Engagement Badge "credit" students attending ADP, CASL, Library, Honors, student organizations, etc. and sponsored civic engagement activities can earn various digital badges in leadership and entrance into the LEADS Honor Society.

## Landscape:

NJ's voter registration laws are not really restrictive and are among a number of states whose laws were expansive in recent years. NJ enacted legislation permitting online voter registration, expansive early voting options, and continued flexibility with vote by mail.

There is one issue that inconveniences our students on campus and this is vote by mail procedures. Our campus mail system is emerging and there is not a US postbox on campus. Students who request a vote by mail ballot would still have to leave campus or locate a location on campus where they could actually mail in their ballot.

We do have a secured vote by mail dropbox on campus, however, dropboxes are specific to county residents. Since we are in Passaic County, NJ, only Passaic County voters should use the campus dropbox. Resident students from outside of Passaic County should not use the secured dropbox.

In the future, NJ could consider permitting all voters to use the secured dropboxes regardless of county ballot/residency, however, this would require additional logistical procedures for the state and perhaps delay vote tabulation, especially in regards to local elections.

“Looking Closer”, exhibited directly below, provides comparative NSLVE 2022 data on voting and voter registration for William Paterson University students including 2014, 2018, 2020, and 2022. Given that these data are based primarily on midterm elections and fewer people vote during such elections and overall enrollment at WP is down since 2018, these data reported a decline in all significant categories except for growth in number of students who registered to vote with an increase in the voter registration rate in 2022.

The table below presents comparative data from the 2016 the 2020 election cycles with 2018 midterm elections also reported. The data provide important information on voting registration and yield rates. We used these data to plan our 2024 voter election cycle action plan.

William Paterson University is now a HSI and MSI. With a decline in overall student enrollment since 2016, a fast-growing diverse student population, and increased enrollments in online degree programs, our goal is to increase our overall voter registration and yield rates among our online degree students and our diverse student population. While we will be discussing how to offer more voter education and programming for our online students, our primary focus is on our commuter and residential student populations. At the end of our of action plan, please see the Addendum for programs and events that we have offered since spring 2022 aimed at meeting our increased overall target goals.

It is our aim to further increase our voter registration and voter turnout rates among all racial and ethnic groups in the 2024 election cycle. Our voter education and voter registration campaigns on campus focus on educating our students on the issues on all

ballots and for all elections. We aim to increase student participation in campus elections, civic engagement on campus, service-learning opportunities, midterm elections, classroom discussion, special events, lecture, etc. and awareness of social and political issues relevant to and of interest to our students' lived experiences.

**Goals:**

Our institution's nonpartisan democratic engagement goals are to:

- Increase the student voter turnout rate by 10%-15% in 2024 compared to 2020 and by 5%-10% in 2026 compared to 2022.
- Increase the student voter registration rate by 20% in 2024 compared to 2020 and by 10% compared to 2022 in 2026.
- Include voter registration at new and transfer student orientations for fall 2024 and beyond.

**Strategy:**

William Paterson University will implement these strategies to increase nonpartisan democratic engagement and student voter participation. Please see below for actions taken to implement our 2024 action plan.

1. At New Student Orientations, the Office of Campus Activities, Service and Leadership (CASL) provided voter registration information at Services Fair tabling for new students.
2. A Civic Engagement email was sent to all students at the start of each fall semester for the past six years outlining the importance of service, opportunities, and links for information on voter registration and voting. Students were provided with the opportunity to register to vote through WP Connect.
3. Every 9/17/, Constitution Day, we present a major kick-off event for our Constitution Week of activities.
4. Our Student Government Association holds elections each semester for new Senators, with a swearing in ceremony at a fall meeting. This year it was held on on 09/24/2024.
5. We participate in the NJ Ballot Bowl Kick-Off and Competition every fall. WP has competed since it began seven years ago and has consistently placed in the top three for our category. We just hosted the state's biggest Ballot Bowl Kick-Off (as

reported by the Lt. Gov's staff) on 9/17/24 in which Lt. Gov. Way and over 250 people attended. This year's event was on National Voter Registration Day and Constitution Day.

6. CASL and the Library do tabling for voter registration and pledges throughout the fall semester until election day. We also work with student organizations to help register students. For this semester, CASL created flyers with QR codes to voter registration and a pledge to vote (through All in Challenge) links placed all over campus, residence halls and on tables in the dining hall. Staff are also working with Athletics, Honors and EOF to register students at their meetings and events.
7. CASL sent students to the annual EngageNJ Thrive Conference in February 2024, which focused on a variety of ways student can incorporate service and civic engagement into their careers.
8. WP LEADS Civic Engagement Badge awards "credit" for students attending ADP, CASL, Library, Honors, student organizations, sponsored civic engagement activities, and presentations and performances.
9. Marketing and Public Relations at WP has launched a mini-campaign on social media to encourage our community to vote and to post photos and or videos of themselves dropping off ballots or sporting "I voted" stickers as a means to encourage their fellow Pioneers to vote, too. We are using the hashtag #WPVotes on all such posts. We made our first post today, 10/01/2024, with President Richard Helldobler dropping off his mail-in ballot. <https://www.instagram.com/p/DAL-Lr5pPyl/>

## Evaluation:

We will evaluate our action plan in the following ways:

William Paterson University participates in the NSSE data collection process and the Office of Institutional Effectiveness also administers several surveys using various metrics to measure the topline goals outlined at the beginning of our action plan above. In addition, the Office of Campus Activities, Service and Leadership are given yearly KPI's from the President that measures the impact of civic engagement on voter registration and voter yield.

In addition, right before the pandemic, our American Democracy Project Committee launched a campus survey with the aim of studying students' attitudes towards politics, political involvement and political awareness. We used measures to study voter registration, voter turnout, and interest in and understanding of civic engagement and similarly-related issues. We also asked opened-ended questions soliciting ideas from students on what types of programming around these topics they would like offered on or off campus. The pandemic hit and that was also the year of the Census. Our response rate was low and the priority of the moment was dictated by the pandemic. We closed the survey with a small response rate. Now that we are living in a post-pandemic culture and our institution is experiencing new and exciting enrollment trends and a decolonized

curriculum and workplace, we will launch a survey in spring 2025 to revisit these issues as we plan more strategically for the next election cycles.
